- Levels: Beginner (must know how to serve & keep score), Intermediate (tournament or match play experience) & Advanced (Championship & Super Championship); levels may be combined
- Date: Saturday, December 10 - Sunday, December 11, 2011

- Format: Six (6) game set with No-Ad Scoring for 10's through 18's; 8's play 2 out of 3 games to 7 points on 36' courts; Players guaranteed two rounds in singles, doubles may be single elimination
